

## Privacy policy terms of LOCCA lost&found services GmbH

### 1. General

Personal data (first name, last name, zip code, address, telephone number, fax number, e-mail, address, website address, bank details) will be processed by LOCCA lost&found services GmbH exclusively according to the Austrian Data Protection Act.

### 2. Automatic data collection

The following data, which is transmitted by your Internet browser to LOCCA lost&found services GmbH, is collected for technical reasons:

- Version and type of the browser
- Operating system
- Referrer URL (the website from which you visit us)
- the website you are visiting
- Date / time of access
- IP Address

This collected data is not used in order to draw conclusions about a particular person, and is not stored after the completion of your visit.

### 3. Inventory data

otherwise used by LOCCA lost&found services GmbH for advertising purposes (information about products, new releases and press events from LOCCA lost&found services GmbH via post, SMS or e-mail).

#### **4. Usage of Google Analytics on Locca websites**
